**WHEREAS:**

- The parties entered into a Compounding and Repackaging Pharmacy Agreement, with an effective date of 4/1/25;

- The parties have agreed to amend the Agreement as set out below (the "Amending Agreement");

THEREFORE, the Community Pharmacy and the Compounding and Repackaging Pharmacy mutually covenant and agree as follows:


1. Article 4.7 of the Agreement is replaced with the following:  
4.7 To ensure that this Agreement remains consistent with any new directions of the Council of the College made under section 19(a)(i) of the Pharmacy and Drug Regulation, after the effective date of this Agreement, the parties agree to renegotiate the terms of this Agreement to comply with those new directions and to make the necessary amendments to this Agreement in accordance with articles 5.4 and 19.3 within 30 working days of the issuance of any new directions.
2. Article of 19.1 of the Agreement is replaced with the following:  
19.1 Subject to article 19.2 this Agreement contains the entire understanding between the parties relating to the subject matter contained in it and supersedes all prior oral and written understandings, arrangements and agreements relating to the subject matter contained in it.
3. Article 20.2 of the Agreement is replaced with the following:  
20.2 The Parties shall:
  - (a) keep minutes of the meeting referred to in article 20.1;
  - (b) ensure that the minutes are signed by the licensee of each party;
  - (c) provide a copy of the minutes to the Registrar on request.
4. As of the Amending Agreement Effective Date, the Agreement is amended as set out above. In all other respects, the Agreement is confirmed and remains in full force and effect.

WHEREFORE THE PARTIES to this Amending Agreement have duly executed this Amending Agreement to be effective as of the date written above.
